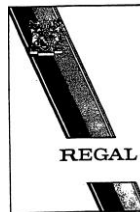

TAKE NOTICE that the Registrar is in receipt of a notice of opposition filed by Belize Sugar Industries Limited, (The Opponent), of Tower Hill, P.O. Box 29, Orange Walk Town, Orange Walk District, Belize, against trademark Application No. 15127.19, filed on the 13th day of February, 2019 by Belize Sugar Cane Farmers Association (The Applicant), of San Antonio Road, Orange Walk Town, Belize, for the registration of the following trade/service mark, as proprietor thereof:



1. The Opponent, Belize Sugar Industries Limited, is the proprietor of the internationally well-known trademarks “BELIZE SUGAR”, and “BELIZE SUGAR” and device”, which are registered in Belize.
The details of the opposing trademark registrations are as follows:
 - Registration no.10589.14 BELIZE SUGAR for goods in class 30 for “molasses for food; brown sugar; brown free-flowing sugar; invert sugar syrups.”, registered on 07 January 2015;
 - Registration no. 10590.14 BELIZE SUGAR and Device for goods in class 30 for “molasses for food;/brown sugar; brown free-flowing sugar; invert sugar; invert sugar syrups.”, registered on 07 January 2015;
2. By virtue of its said trademark registrations in Belize, pursuant to section 24(1) of the Trade Marks Act the Opponent has exclusive rights to the trademarks, and pursuant to section 38 (1) of the Trade Marks Act the Opponent’s said trademarks are “earlier trademarks”.
3. By virtue of its extensive use, promotion and advertisement of its said trade marks in Belize, the words “BELIZE” and “SUGAR” are distinctive of the Opponent and its goods, including its widely known molasses and sugar, as the words “BELIZE” and “SUGAR” are two of the most distinctive elements of the Opponent’s trademarks. Neither the words “BELIZE” nor “SUGAR” are common to goods in class 30, and accordingly same are exclusively associated with and distinctive of the Opponent’s goods.
4. The trade mark “BELIZE SUGAR CANE FARMERS ASSOCIATION and device” which the Applicant has applied to register is similar conceptually to the Opponent’s earlier trademarks in the following ways:
 - (i) The words “BELIZE” and “SUGAR” are commonly known for identifying the Opponent as the source of goods covered under the Opponent’s earlier trademarks.
5. The application for “BELIZE SUGAR CANE FARMERS ASSOCIATION and device” is in respect of goods in class 30, namely, molasses for food; molasses syrup; raw sugar; white sugar; brown sugar; unrefined sugar, namely, evaporated sugar cane juice. These goods are identical or similar to goods for which the Opponent’s said trademarks are registered and used.
6. By virtue of paragraphs 4 and 5 above, the trade mark “BELIZE SUGAR CANE FARMERS ASSOCIATION and device” is not eligible for registration pursuant to Section 37 (2) of the Trade Marks Act, as there exists a likelihood of confusion on the part of the public, including likelihood of association with the Opponent’s earlier trademarks.
7. Further and/or in the alternative, the Opponent’s earlier trademarks have a reputation in Belize and throughout many other jurisdictions, and the use of the “BELIZE SUGAR CANE FARMERS ASSOCIATION and device” by the Applicant would take unfair advantage of and be detrimental to the distinctive character and reputation of the Opponent’s earlier trademarks.
