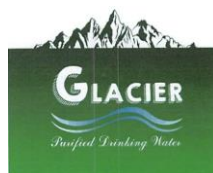

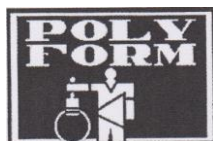

5.
