2. By virtue of its said trademark registration in Belize, pursuant to section 24(1) of the Trade Marks Act the Opponent has exclusive rights to the trademark, and pursuant to section 38(1) of the Trade Marks Act the Opponent’s said trademark is an “earlier trademark”.
 3. The trade mark “ROOTING” which the Applicant has applied to register is similar phonetically and visually to the Opponent’s earlier trade mark in the following ways”
