3. the mark contained in the Applicant’s said Application No. 10198.13 contravenes sections 37(3) of the Trade Marks Act, Chapter 257 of the Laws of Belize, Revised Edition 2000 and amendments and should not be registered by virtue of the fact that it is identical with or similar to the Opponent’s trade mark as earlier trade mark and is to be registered for goods or services which are not similar to those for which the Opponent’s trade mark as earlier trade mark is protected but the Opponent’s trade mark as earlier trade mark has a reputation in Belize and the use of the mark contained in the Applicant’s said Application without due cause would take unfair advantage of, or be detrimental to, the distinctive character or the repute of the Opponent’s trade mark;
4. further and in the alternative, the mark contained in the Applicant’s said Application No. 10198.13 contravenes section 37(4)(a) of the Trade Marks Act and should not be registered by virtue of rule of law (in particular, the law of passing off) protecting and unregistered trade mark or other sign used in the course of trade;
5. further, and in the alternative, the mark contained in the Applicant’s said Application No. 10198.13 contravenes section 35(6) of The Trade Marks Act and should not be registered by virtue of the fact that the Applicant’s application for registration of the said mark is made in bad faith;
6. the Opponent respectfully requests that the subject application for the Applicant’s trade mark be refused registration.

The Applicant is required to submit a response to this notice, to the Registrar, no later than 30 days from the date of publication of this notice.
