The Opponent opposes the above trademark Application on the grounds that:

1. DC Shoes, Inc. (hereinafter referred to as “the Opponent”) was founded by Kenneth Block and Damon Way, Incorporated in 1993, and is a leader in performance skateboarding shoes and a renowned action sports brand. It has since grown to be a global leader in men’s, women’s and kids’ casual apparel, snowboard boots, technical outerwear, and related accessories. The Opponent is associated with snowboarding, surfing, BMX, and motorcross and collaborates with artists, musicians and cultural influencers. These connections enable the Opponent to develop signature products and support its promotional efforts.
2. As one of the cornerstones of its marketing strategy, the Opponent has built a world-class team of professional skateboarding, snowboarding, surfing, BMX, motorcross and rally athletes that exemplify and enhance its DC brands, develop its signature products, and support its promotional efforts.
3. The Opponent is well-known throughout the world including Latin America in, *inter alia*, designing and manufacturing of footwear, apparel, bags, and related accessories, and has used the Opponent’s DC Logo trademark continuously and extensively for a very substantial period of time. The Opponent first commenced its business as early as 1993 in the United States of America. Since its incorporation, it has rapidly expanded its operations worldwide, including Latin America. The Opponent first commenced use of the Opponent’s  trademark at least as early as March 1997.
4. The Opponent is the common law and registered proprietor of the trademark registration for the  mark and its variants and extensions throughout the world in Class 25.
5. The Opponent has applied and/or obtained registration for the  mark in respect of a variety of clothing, footwear, and headgear in Class 25 in various countries.
6. The Opponent has obtained copyright registration for the  mark in the People’s Republic of China, on April 22, 2010 with Registration No. 2010-F-025541.
