The Opponent opposes the above trademark Application on the grounds that:

- 1. The Opponent, Major League Baseball Properties, Inc., is the proprietor of the international well-known trademark "
 and is utilized by its subsidiary, OAKLAND ATHLETICS MAJOR LEAGUE BASEBALL club (also commonly known as the
 "A's") and the related fame of the club's marks consisting of a distinctively stylized letter "A's" (as shown above), which is used
 and registered, worldwide, except for Belize, for a wide variety of goods and services, including goods in Class 25.

- 4. By virtue of its extensive use, promotion and advertisement of its said trade marks in Belize and Central America, the image and

concept ", are distinctive of the Opponent and its goods, including its world known baseball club. Neither the word "A's" nor the stylized "A's" are common to goods in class 25, and accordingly same are exclusively associated with and distinctive of the Opponent's goods.
