





- 1. the invalidation follows an opposition filed on or around the 16th day of march, 2011 by the Claimant (as "opponent" therein) against the Registrant (as "Applicant" therein) and against the registration of the Registered Mark;
- 2. this invalidation also follows the Claimant's application to register its "Empire" mark, filed on or around the 16th day of March, 2011 and bearing Application No. 7634.11;
- 3. by notice of Ruling dated the 13th day of September, 2011, the Belize Intellectual Property Office ("BELIPO") ruled against the Opponent, "*due to the failure of the Opponent to leave evidence by way of Affidavit in support of its opposition*";
- 4. the said Notice of Ruling was issued following a refusal of a request by the Claimant (while as Opponent of the said Opposition) for an extension of time to file the required Affidavit and was not issued on the substance or merit of the Opponent's case itself, or the grounds thereof;
- 5. the said registered mark was thereafter registered by BELIPO on the Register of Trade Marks;
- 6. by Non-Final Action dated the 23rd of September, 2011, BELIPO has further objected to the registration of the Claimant's said Application No. 7634.11, "on the grounds that the trademark [contained in Application No. 7634.11] is identical to an earlier trademark [the Registered Mark] and that the goods for which the trademark [contained in Application No. 7634.11] is applied for are identical for which the earlier trademark [the Registered Mark] is protected";
- 7. St. Vincent Manufacturing Company Limited ("SVMCL") was incorporated in St. Vincent in 1946 and operated as the manufacturer and distributor of the local brand of tobacco goods in that country known as "Empire". St. Vincent's total market volume was estimated at 64 million sticks (cigarettes) in 2006 and by that year it was also estimated that SVMCL had 51% (32 million sticks) of that estimated 2006 volume. In December, 2008 BAT Caribbean S.A., the Claimant herein, purchased from SVMVL the entire right, title and interest in such "Empire" related trade marks, copyright works and other intellectual and trade property. Since the said purchase, BAT has continued to market, distribute and sell the Empire (also hereinafter referred to as "BAT Empire") brand in St. Vincent;
- 8. there has being no use of the BAT empire mark by the Claimant in Belize so far but the Claimant, based on a business strategy, made the decision of expanding the use of the BAT empire mark from St. Vincent to other Caribbean markets (where applications have been already filed for registration of the trademark Empire), including Belize, therefore BAT has a truly bona fide intention of using said mark in Belize;
- 9. the Claimant is a national of the Republic of Panama, with physical offices and operations in that country and with registered office specifically in Via Fernandez de Cordoba, Corregimiento de Pueblo Nuevo, Panama City, Panama, and the BAT Empire Mark is a well-known trade mark which qualifies for protection under the Paris Convention for the Protection of Industrial Property, in particular but not limited to Article 6bis thereof, which is given full effect under Belize law (being the trade Marks Act, Chapter 257 of the Laws of Belize, Revised Edition 2000);
- 10. the Registrant mark contravenes section 37(1), 37(2), 37(4)(a) and 38(1)(b) of the Trade Marks Act, Chapter 257 of the Laws of Belize, Revised Edition 2000 and amendments and should be invalidated and consequently deregistered by virtue of the fact that it is similar to the Claimant's trade mark as earlier trade mark and is to be registered for goods or services identical with or similar to those for which the Claimant's trade mark as earlier mark is protected;
