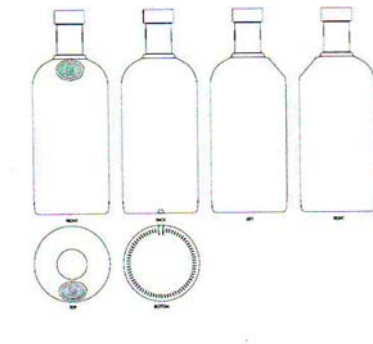

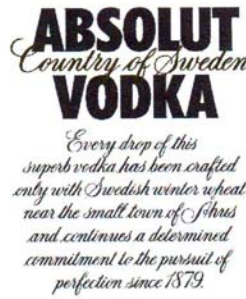

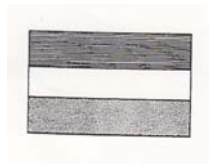

2. Comité International Olympique opposes registration of the OLYMPIKUS & THREE RINGS trade mark seeking registration in Class 25 on the following grounds:
  - (a) the Applicant is seeking registration in Class 25 for goods: clothing namely, gymnastics, cyclists’ clothing, jackets [clothing], knitwear [clothing], leggings, tee-shirts, overcoats, pants, sports jerseys, stockings, socks, swimsuits, bathing trunks, bathing suits; footwear namely, gymnastic shoes, sandals, slippers, beach shoes, athletic shoe, leisure shoes, football shoes, tennis shoes, sneakers, athletic and leisure boots, half-boots, lace boots, football boots, ski boots; caps [headwear] and hats which are similar to the goods registered under the Opponent’s registered trademark, namely, “clothing, shoes and headgears” in class 25;
  - (b) though the applicant’s trade mark  consist of both word and figurative element, the word component coincides almost totally with “THE OLYMPICS” and the sound OLYMPICS/OLYMPIKUS is virtually identical. In addition, the figurative element of the trade mark which is the three rings will most likely cause the public to create some association and confusion with the Opponent’s trade mark which also consists of three rings;
  - (c) the Opponent opposes the Applicant’s trademark on the ground that the word element OLYMPICS with the three rings create some association and confusion with the Olympic Games and this may give rise to “passing off” which is an infringement of the Opponent’s proprietary rights;
  - (d) the Opponent opposes the Applicant’s trademark on the ground that it is similar to its previously registered trademark and because the application is being made in bad faith.
3. The Opponent is also the registered proprietor of trade marks: OLYMPIC, OLYMPIC & BUTTON RINGS, OLYMPIC COLLECTION & RINGS, OLYMPIC GAMES & RINGS in numerous countries around the globe including Albania, Austria, Barbados, Bulgaria, China, Croatia, Cuba, Cyprus, Czech Republic, Denmark, Egypt, Estonia, France, Finland, Germany, Greece, Hungary, Iceland, Kenya, Liberia, Netherlands, Portugal, Romania, Spain, Sweden, Turkey and Zambia among others and has exhausted funds in promoting the Olympic Games under its registered trade mark.






