

  - (c) SOL BRAVA (name and logo), No. 2886.05, registered on the 27<sup>th</sup> day of January, 2005;
- 2. the said marks are registered in respect of Class 32;
- 3. the Opponent is also the registered proprietor of the SOL mark (name only) and other similar SOL marks which are registered in other jurisdictions and which are used by the Opponent and are well-known in Belize;
- 4. the Opponent's well-known trademarks are also entitled to protection under the Paris Convention;
- 5. the Applicant's trademark is similar to those of the Opponent's and the Applicant's trademark is seeking to be registered in the same Class and for goods or services identical with or similar to those for which the Opponent's trademarks are registered and protected as earlier trademarks;
- 6. the Opponent's trademarks have gained international recognition and the Applicant's trademark, if registered, is likely to cause confusion which may mislead the public into thinking that the marks are associated with or are owned by the same company;
- 7. if the Applicant's trademark is registered, there exists a likelihood of confusion on the part of the public, which includes the likelihood of association with the Opponent's earlier trademarks;
