It is not disputed that "V" and "B" in Spanish sound the same. Since the Application seeks to cover "fruit juice, non-alcoholic <u>beverage</u>" in Class 32 and "non-alcoholic energy drinks, sparkling fruit wine" in Class 33, the Opponent submits that the mark consists exclusively of the indication of the kind of goods being produced by the Applicant (namely, drinks and beverages) based on the similarity in pronunciation and spelling to the Spanish word BEBIDA.
- 2. Opponent opposes the mark based on absolute grounds for refusal relying on Section 35(1)(b) of the Act, in that the mark BEVIDA is devoid of any distinctive character. The word "BEVIDA" is inherently descriptive for such consumable products as drinks and beverages based on the Spanish translation "BEBIDA" as explained in 1 above.
