 - (a) the mark is confusingly similar as the Philip Morris' mark appears at the bottom of the applicant's label;
 - (b) the goods applied for are identical or similar (both in Class 34);
 - (c) the mark 4388.07 was registered first in Belize, on February 20, 2007;
 - (d) the targeted consumers are identical or substantially similar in that these are persons looking for tobacco products;
 - (e) the channels of trade are identical or substantially similar in that the products are sold where tobacco products are available.







