

The Opponent has and is continuously achieving immense success in its commercial expansion to be the leader and largest manufacturer and trader of food and beverage products in the world. The Opponent's food and beverage products include famous trademarks such as KRAFT, PHILADELPHIA, OREO, RITZ, CHIPS AHOY!, TANG, MAXWELL HOUSE, MILKA, OSCAR MAYER, PLANTERS, among others;
