

Title: "HOPE GENERATOR" (Harmonic Oscillating Power Electric Generator)

Abstract: A solid state electrical generator which may employ sound or various other resonant frequencies to induce and produce AC potential. One embodiment of the present invention consists primarily of a central C-Core (1a) made from METGLAS ALLOY 2605SA1, four primary induction wire coils consisting of a pair or set of first stage (2a) and second stage (2b) primary coils, and two output coils (2c). The four primary coils are situated around each of the four end posts located on each of the two halves of the C-core (1a) where they fit together to form one complete core. The two output coils (2c) are situated along the valley (or) center of the U shape located on each half of the C-core (1a). All coils are typically wound from left to right in a clockwise fashion, however coils wound from right to left will simply require modifying the way in which jumper wires will be configured and/or connected. Additional coils can also be added to the exterior of the HOPE Generator to collect and relay additional current either back into the unit or to be used for entirely other purposes altogether.
