





The design versions of these trade marks are associated with TV programs, each aimed as a series of crime dramas (collectively referred to as "CSI Programs"). These programs are also distributed on videotapes and DVDs;

- 3. Alliance Atlantis distributes the CSI Programs and owns all rights to the CSI Trade Marks worldwide, other than the United States. In the United States, these rights are held by CBS Broadcasting, Inc., the partner of Alliance Atlantis in the production and protection of this series;
- 4. Alliance Atlantis owns trade mark applications and registrations for each of the three CSI Trade Marks in more than 130 countries around the world;
- 5. the original of the three CSI Programs, CSI: CRIME SCENE INVESTIGATION, was first broadcast in approximately September 2000 in the United States. The other two CSI series, CSI: MIAMI and CSI: NY, were created and subsequently broadcast as the popularity and success of the original series grew. The CSI Programs have been continuously broadcast, since their first introduction, in more than 200 countries around the world. Typically, one episode of each of the three CSI Programs is broadcast weekly throughout the regular viewing season and re-broadcasts of episodes previously aired continue through the year. In some jurisdictions, such as Canada and the United States, re-broadcasts are aired multiple times daily;
