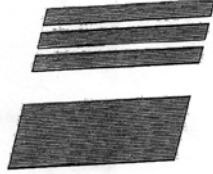





NOW THEREFORE, this present patent grant unto the Applicant, and to any subsequent legal representatives of the Applicant, all the benefits of the Patents Act for a period of twenty years from the 27th day of November, 2002, and whose priority claim is based on United States of America Patent Application No. 60/333,460 filed on the 27th day of November, 2001, and subject to the conditions contained in the Patents Act and Regulations made thereunder and to any adjudication of the Supreme Court of Judicature affecting those rights.
