





Entry into force of the Common Regulations: Forms

1. In view of the entry into force, on April 1, 2004, of the Common Regulations under the 1999 Act, the 1960 Act and the 1934 Act of the Hague Agreement (see Information Notice No. 12/2003), the attention of users of the Hague system is drawn to the following.

- a request for the cancellation of the recording of the appointment of a representative (form DM/9).
