5. The Opponent has prior to the enactment of the Trade Marks Act, CAP. 257, published general Cautionary Notices of their trademarks in Belize stating the ownership of the trade mark CLOROX and Design for "bleach and other laundry products" in International Class 3.




The Applicant is hereby invited to file an answer to the notice of opposition not later than September 26, 2003, under Rule 33 of the Trade Marks Rules (No. 3 of 2002), to the undersigned, indicating the grounds on which the Applicant relies and any facts alleged in the notice of opposition that the Applicant admits.
