2. Monster has Prior Registrations in Belize of the "M CLAW DESIGN" trade mark under Reg. No. 11812.15 registered on the 12th day of April 2016 and the "M MONSTER ENERGY & Design" trade mark under Reg. No. 12714.16 registered on the 28th day of February 2017 being shown hereinbelow:

3. Monster uses the marks cited in the previous paragraph in Belize. Monster's core business is the production, distribution, marketing, and sale of energy drinks. The Opponent uses the marks cited above on goods available in Belize to promote its core business, as an ancillary business to its core business, or both. Monster engages in extensive promotion of its beverages through the sponsorship of sporting events, athletes, concerts and musicians, and video gaming. In connection with its promotional activities, including but not limited to these sponsorships, Monster uses the Claw Icon and the trademarks that contain it, including those cited above, through the sale or give away of goods that bear the icon.

Therefore, it is the Opponent's position that the Applicant has filed its application in bad faith and with full intention to exploit the Opponent's goodwill and to deceive the general public as to the origin of its services.
  - i) The proprietor of the earlier right has **NOT** consented to the Applicant's registration.




2. The Opponent respectfully requests that the subject application for the Applicant's trademark be refused registration.
3. In order to show its good faith regarding the Opponent Mark, the Opponent has simultaneously with this opposition presented a trademark application to the Belize Intellectual Property Office containing word elements, designs, and combinations thereof related to the Opponent's Mark "**TROPIC AIR**" which has been utilized by the Opponent since the year 1991 (over 31 years).


