The Applicant hereby gives notice that the following are the grounds on which it relies as supporting the above trade mark:

1. The mark “” has been in existence and in use, by the Applicant, since 1991 throughout the country of Belize. Hence, it has been used in the course of trade by the Applicant for over thirty-two (32) years and has acquired a very high reputation and goodwill in Belize.
2. The Opponent's mark “TROPAIR” has not yet been registered in Belize. While a trade mark application, No. 17110.21, has been filed for that mark it is not capable of being registered pursuant to section 37(4)(a) and (b) of the Trade Mark Act.
3. As such, pursuant to section 37(4)(a) of the Trade Mark Act, in particular the law of passing off, the Applicant's mark “” is protected despite being an unregistered trade mark since it has, since 1991, being used by the Applicant in the course of its trade.
