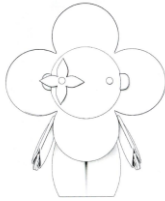

**TAKE NOTICE** that the Registrar is in receipt of a notice of opposition filed on the 22<sup>nd</sup> day of April 2024, by **Abbott Laboratories** (The Opponent), of 100 Abbott Park Road, Abbott Park, Illinois 60064, United States of America, against trademark International Application No. 1699692 with subsequent designation date of 10<sup>th</sup> day of May, 2023, by **Pharmalys Laboratories SA** (The Applicant), of Schochenmühlestrasse 2 CH-6340 Baar (Switzerland), for the registration of the following trademark, as proprietor thereof:



The grounds of opposition are as follows:

1. The Applicant's trade mark application with International Application Number 1699692 for  is similar to the Opponent's earlier trade marks in Belize, namely **PEDIASURE** (Reg. No. 6498.09) first registered in 2009 and subsequently renewed as of December 21st 2019 for goods in International Class 5 and  (Reg. No. 13354.17) registered on November 10th 2017 for goods in International Classes 5 and 29.
2. Additionally, the Applicant's trade mark application is for registration for goods in International Classes 5 and 29 which are identical to and similar to those for which the Opponent's earlier trade marks are registered.
3. As a result, there exists a likelihood of confusion on the part of the public, which includes the likelihood of association of the Applicant's trade mark with the Opponent's earlier trade marks.
4.
